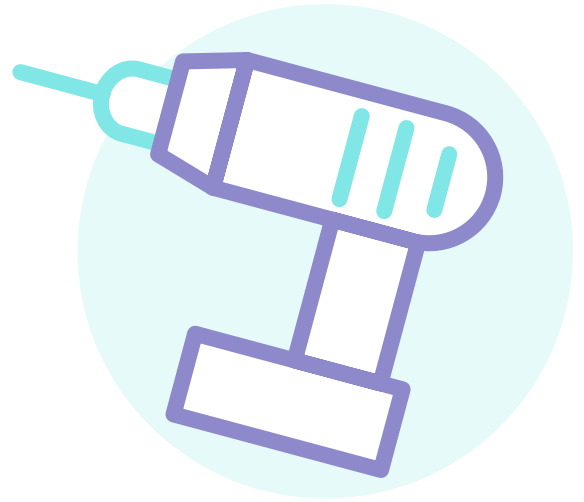

Rating highlights

- Contractors are rated off of their payroll and their TIV/LOI
- Payroll has special considerations for owners

Eligibility highlights

- Up to \$2M in revenue
- Up to \$1M in payroll
- No more than 30% in subcontracted work
- Not a market for contractors who work on projects and/or are located in the boroughs of NYC and the NY counties of Westchester, Rockland, Nassau, Suffolk and/or Erie
- New Ventures are eligible
- Locations can be up to 50,000 sqft
- No employee limits

Account parameters

- \$4.75M per location
 - \$9.5M per account
 - No more than three claims in the last five years, and no more than \$20,000 total incurred (CAT claims not counted*)
- *If the ISO has issued a CAT code for the event, it is considered a CAT claim

 - B10 1 79 10 20 Waiver of Transfer of Rights Against Others To Us (aka Waiver of Subrogation)
 - B10 1 100 Contractors Enhancement
 - B10 1 01 10 20 Additional Insured by Contract, Agreement or Permit (except NY)
- BP 14 88 07 13 Primary and noncontributory – other insurance condition (except NY) is available upon request (reach out to help@attuneinsurance.com)
