PO AND INVOICE MANAGEMENT

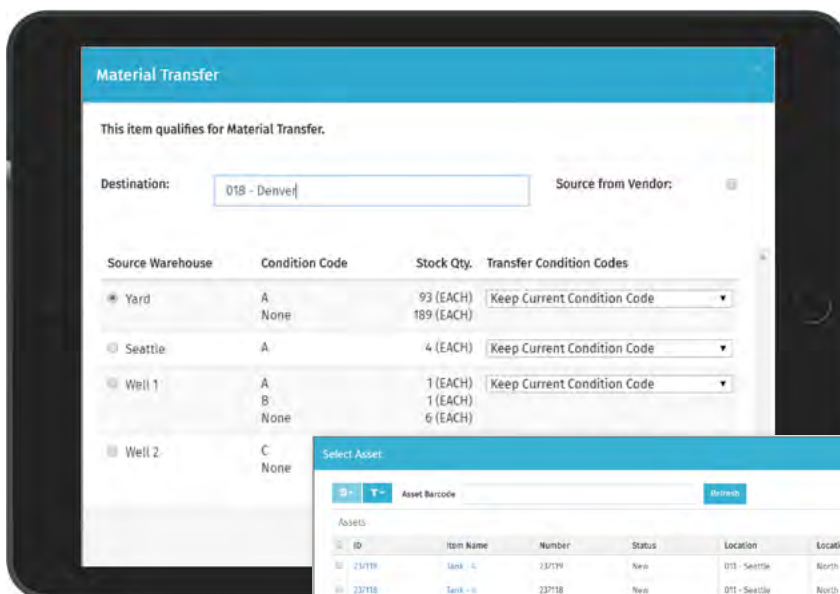
- Automatically generate POs and deliver to vendor after approved requisitions
