REACH DECLARATION OF CONFORMITY

Dear Customer,

The European Union's Regulation (EC) No 1907/2006 on the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) entered into force June 2007. This declaration presents our current position regarding the REACH regulation.

Mirka is a downstream user of chemicals. We use a Mirka Restricted Material List towards our suppliers which contain, among others, the Candidate List of Substances of Very High Concern (SVHC), REACH Annex XIV (List of substances subject to authorization), and REACH Annex XVII (Restrictions on the manufacture, placing on the market and use of certain dangerous substances, mixtures and articles). Before using a new raw material, we check if the substances are included on the Mirka Restricted Material List, we ensure that the substances are REACH registered and that our area of use corresponds to the area of use of the supplier.

We support the aim of the REACH regulation, prohibiting SVHCs since 2014 in our products and we continuously work on replacing these substances as the candidate list expands, when technically feasible. When a substance enters the SVHC candidate list, the use of the substance is not automatically forbidden. The substance is still allowed to be used considering the application and safety conditions. We follow updates to the lists and each update is reviewed and checked against our raw materials and products. Changes to the lists or our raw materials can lead to a revaluation of this statement.

The SCIP database, established under the Waste Framework Directive (WFD), contains information on substances of concern in articles as such or in complex objects (products). Companies supplying articles to the EU market containing substances of very high concern (SVHCs) as per the Candidate List in a concentration above 0.1 % w/w must submit information on these articles to ECHA via the SCIP database. Coated Abrasives, Polishing Compounds, Mirka Essentials

We hereby confirm that, to the best of our knowledge, our coated abrasives, polishing compounds and Mirka Essentials products do not contain Substances of Very High Concern (SVHCs) above the threshold value of 0.1 % w/w (last updated January 21, 2025), do not contain substances on REACH Annex XIV above the threshold value of 0.1 % w/w and that they comply with the restrictions in Annex XVII to REACH.

Power Tools

We hereby confirm that, to the best of our knowledge, our Power Tools do not contain substances on REACH Annex XIV above the threshold value of 0.1~% w/w and that they comply with the restrictions in Annex XVII to REACH.

Since 2018 the Candidate List includes lead as an element, lead metal, CAS 7439-92-1. Lead has been restricted for many years under the RoHS Directive (0.1% limit), however with certain exemptions. Lead content above 0.1% in our products (articles) is only present if it lives up to the exemptions under the RoHS Directive.
