

Challenge


A large financial services company, with a corporate headquarters and several small financial advisor offices needed a more efficient way for their home office to take in all of the front-line requests that came from their satellite locations.. This was quite a complex and time-consuming task—with over 2,500 satellite offices throughout the country.

Solution

This financial services company began using Conga Orchestra to take in all front-line requests from their satellite office locations. 100+ request types are now entered as new Salesforce records and based on rules, Orchestra initiates the process. For example, new account, withdrawal, trade, beneficiary change—any of these types selected could drive a process. Orchestra ensures the right data is collected to provide the proper context and data for processing downstream.
