The company operates in over 100 countries and boasts an impressive lineup that includes electric and hybrid vehicles, sports cars, sedans, trucks, and SUVs designed for driving pleasure, safety, and environmental responsibility. The situation

In the dynamic world of automotive manufacturing, the company realized that efficiency, precision, and compliance with regulations are critical in ensuring operational success. In its pursuit of supply chain excellence, the company embarked on a journey to revolutionize its manufacturing operation in Europe by setting up a parts import facility in the UK and collaborating with a partner in Germany to innovate and assemble various models tailored to the local market.

The challenge

As a global company with intricate supply chains, it faced significant challenges managing the storage, distribution, and customs compliance of its imported parts and vehicles as it increased its focus on the European market. As importing non-EU vehicle parts became a regular part of its operations over time, the new challenge was to ensure that these parts were efficiently processed and re-exported to qualify for the Inward Processing relief program that suspends import duties and Value Added Tax (VAT) on certain components. Failure to meet the program's requirements would result in additional customs duties and taxes, potentially jeopardizing its competitive edge.

The solution

The company strategically decided to implement a bonded warehouse solution to provide end-to-end visibility into its inventory, ensure customs compliance, and optimize its European operations with two bonded warehouses in the UK.

The solution focuses on three main elements of duty management provided by e2open bonded warehouse management capabilities part of the Global Trade suite of connected applications:

• **Customs compliance:** Compliance with customs regulations is crucial for any international enterprise. The software facilitated the generation of required customs documentation, provided electronic communication with customs authorities, and ensured that import declarations were accurate and timely.



• Integrated process: Seamlessly integrating Inward Processing within the bonded warehouse software allowed for effective management of component parts and facilitated hassle-free re-export or circulation of finished products.
