Support for Clearance elnvoicing Method


With the clearance-based approach, common across the Asia-Pacific region and in Latin American countries such as Mexico and Brazil, tax authorities must receive, review and authorize each electronic invoice before trading partners can complete the exchange. If a company's invoices and records are not timely or accurate, their supply chains, accounting departments and even their ability to do financial reporting can be significantly disrupted. With elnvoicing, companies maintain complete and accurate records for each transaction, easily and quickly submitting them to the authorities to prevent bottlenecks.
