Accolade Honors Evaluation Process:

All submissions will be reviewed and scored by an Accolade evaluation panel composed of cross-functional areas: clinical, operations, data and actuarial, etc. The panel will review and rank submissions based on their contribution to the delivery of employee benefits.



How to Submit:

Accolade customers are eligible to be nominated though in the interest of promoting the agnostic nature of impact, there is no requirement that all services be provided by Accolade exclusively. The following information should be included in each submission:

- General Information: please provide name, title, company, phone number, email address and affiliation.
- About the Nominee: describe why the nominee should be recognized and the impact they or their organization have made in the field/delivery of employee benefits (500 words or less).
- Achieved Outcomes: (e.g., improved health outcomes, realized savings, innovative ideas) Please be specific about the level of quantitative outcomes and results (cost savings, process improvement, etc.) that the evaluation panel should be made aware of.
- Industry & Civic Contributions: please provide any additional details on any contributions the nominee has made to advance the profession of employee benefits and/or the betterment of the overall workplace.
- Supporting Documentation (optional) – feel free to provide any additional information or documentation that will be helpful to the review panel regarding nominee.
