

Teacher Giveaway: Guatemala EF Exploration (the “Sweepstakes”)

OFFICIAL RULES

1. **NO PURCHASE NECESSARY TO ENTER OR WIN.**
2. **SPONSOR:** This Sweepstakes is sponsored by EF Explore America, Inc. and EF Institute for Cultural Exchange, Inc. (collectively the “Sponsor”) with a principal place of business at Two Education Circle, Cambridge, MA 02141, USA.
3. **ELIGIBILITY:** The Sweepstakes is only open to legal residents of the United States who are full and part-time teachers, faculty or administrators at the middle school, junior high school, or senior high school level, who sign up online, and who are over the age of 21 as of the date of entry, and it is void where prohibited by law. Employees and their immediate family and household members of Sponsor or its affiliates, subsidiaries, advertising and promotion agencies, or suppliers are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations.
4. **SWEEPSTAKES ENTRY PERIOD:** Entries will be accepted online starting on May 4, 2025 at 7:00 am EDT and ending May 9, 2025 at 11:59 pm EDT. Sponsor reserves the right to modify, cancel, or suspend the Sweepstakes entry period in its sole discretion.
5. **HOW TO ENTER:** To enter you must submit an entry using the online form provided at eftours.com. You will receive one (1) entry for taking the previously mentioned actions. The entry must fulfill all Sweepstakes requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Sponsor. You may enter only once per day during the sweepstakes period. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Sponsor.
6. **PRIZES:** The Winner(s) of the Sweepstakes (the “Winner”) will receive a free trip for one educational professional and a guest, who must be over 21, on an educator-only VIP Rewards Tour to Guatemala from July 15, 2026 through July 24, 2026. The prize includes all program and departure fees (including roundtrip airfare on major carriers, nine nights in a shared hotel room, specified meals, and select coach transportation. The prize does not include any insurance fees, money for gratuities, or additional optional travel. All travelers must execute all enrollment materials including the Booking Conditions with the Release and Agreement, and any other required travel documents prior to departure. All travelers must be in possession of the needed travel documents (e.g., a valid U.S. Passport, proof of vaccination, etc.) when required to travel internationally and must meet all visa entry

requirements (if applicable). The Winner will be required to satisfy all eligibility requirements and may be required to complete an affidavit of eligibility. Actual/appraised value may differ at time of prize award. A total of one (1) winner will be selected. The specifics of the prize shall be solely determined by Sponsor. If Winner cannot be contacted, is ineligible, fails to claim the prize within seven (7) days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited, and an alternate Winner selected. Receipt by Winner of the prize offered in this Sweepstakes is conditioned upon compliance with any and all federal, state, and local laws and regulations.
